

REGISTRATION DEADLINE

Super Bird Registration: On or prior to December 13, 2019.

Registrations received via mail must be postmarked on or prior to December 13, 2019.

Early Bird Registration: On or prior to February 29, 2020.

Registrations received via mail must be postmarked on or prior to February 29, 2020.

Regular Registration: Regular registration rates will apply after February 29, 2020.

ABOUT YOUR REGISTRATION

Individuals may register for full conference (Thursday, Friday and Saturday), two days or one day. Expo hall entry is included with all conference registrations.

Expo Hall Only registrations are available, but does not include access to workshops.

PAYMENT METHODS

Conference registration may be paid by cash, check, purchase order or credit card. Registrations must be paid in full prior to admittance to the Conference.

Credit Card Payments: online, fax or mail.
(Visa, MasterCard or Discover Credit Cards ONLY)

Check Payments: mail only (A non-sufficient funds fee of \$25 will be charged for returned checks.)

Purchase Order Payments: email, fax or mail.
If your agency requires payment by purchase order, please contact the CAAEYC office via email at info@caeyc.org. To receive the super bird or early bird rate, a valid purchase order must be received prior to the cut-off date. The payment policy for purchase orders requires that payment be received within 30 days of the PO issuance and no later than the first day of conference. Purchase order registrations are subject to the cancellation and substitution policies. Contact the CAAEYC staff team at info@caeyc.org with questions about the payment policy.

MEMBER DISCOUNT

The discounted conference registration applies to the **Standard** and **Premium** members. In addition, to receive the member discount, you must provide your valid email address that you have on file with NAEYC. **Your email address must be unique to you** – NAEYC/CAAEYC policy requires an email address that belongs to you; generic email addresses are no longer accepted (e.g., info@, center@, etc.). If this information is not provided, it will delay the processing of your conference registration. Call the NAEYC Customer Care Center at (800) 424-2460, option #4, to be sure your membership is current and that you have a valid email address on file.

Join NAEYC online and immediately receive your NAEYC membership expiration date. Or, mail the NAEYC membership application with your CAAEYC conference registration form to the CAAEYC office (*do not mail your Conference registration to NAEYC*). Enclose a separate check made payable to NAEYC for the membership dues. CAAEYC will forward the membership application and payment to NAEYC. Memberships are for individuals only. *Save money – Join NOW!*

CONFIRMATION & CONFERENCE BADGES

All online registrations will be confirmed by email. Your conference name badge will be sent to the mailing address listed on your registration if registered by February 29, 2020. For registrations processed after February 29, 2020, name badges may be picked up on-site. The badge is required for admittance to the conference. **A replacement fee of \$10** will be charged for badges that need to be reprinted on-site.

CANCELLATION POLICY

Cancellations received on or prior to **March 13, 2020**, will receive a 50% refund of conference registration funds. Cancellations received after that date are not eligible for refunds.

SUBSTITUTION POLICY

If you are unable to attend, you may substitute a colleague for your entire registration. There is no sharing of registrations. A written letter and the original conference badge must be submitted to CAAEYC by the original registrant or authorized representative by **March 13, 2020**. For substitutions after the deadline, the substitute must bring the conference badge and written notice to the registration desk to be issued a new badge. **There is a \$10 fee for each on-site substitution.**

CHILD POLICY

To maintain a professional atmosphere, as well as for safety, children under the age of 16 years (including infants) are not permitted in educational programs or in the Expo Hall at any time. If child care is needed, contact your hotel concierge to make arrangements.
